PLEASE NOTE We require A 50% deposit of the total balance to be paid at the time the order is placed and contract is signed. This is to guarantee the date booked & delivery of the order.

Remaining balance is to be paid 48hours in advanced to the event date.

Your total invoice together with payment link will be sent after signing the contract. Payment of the deposit, together with the signed contract ensures your booking is confirmed. The payment link can be used for both the deposit and final payment. Alternatively, you can pay 100% at time of signing.

CANCELLATION AND DESIGN CHANGE FEES

Cancellations and event postponements happen from time to time. To ensure that we meet the needs of our customers, we do allow both under the following conditions: Event cancellations 30 days prior to the event are entitled to full refund of any monies paid. Event cancellations between 5-30 days prior to the event are entitled to a full credit. Event cancellations less than 5 days prior to the event will forfeit the deposit and receive a credit for any other balance of funds paid. In the event of severe weather (as per BOM Warnings) postponements, a full credit will be provided given a minimum of 6hrs notice. OUTDOOR EVENTS

Sunshine, wind and other atmospheric conditions dramatically affect balloon décor. For all outdoor events, classic balloon décor, deliveries, and balloon sculptures CANNOT be guaranteed to withstand inclement weather. Customer should have a secondary plan to include an indoor location for deliveries.

OWNERSHIP OF MATERIALS

Delivery for rentals needs to be approx. 2 hrs prior to an event, depending on the size of the installation the order. Pickup time for rentals, when applicable, is no more than 1 hour after the end of the event. Other times by prior agreement only. All equipment used for the balloon design is the property of "Larnie Balloons" and is used on a rental basis. Customer is fully responsible for providing timely access to the event area for strike and teardown. Should all equipment and materials not be available to retrieve from the location, the customer will be responsible for the replacement costs of the missing equipment or material.

WARNING

Whilst beautiful when installed there are inherent risks with the provision of balloons and related services. Please be mindful that injuries and damages can occur if the materials are not used properly. Children must be supervised at all times. Access to the venue during set up and take down must be restricted and is the responsibility of the customer. Please note that injuries can occur from helium inhalation or injury from lack of oxygen, slipping on broken balloons, latex allergies, children having access to balloons before, during or after events, children putting balloons in their mouths and choking, eye/facial/body injuries from popping balloons, heart attacks from popping balloons, hearing loss due to popping balloons, lesions, abrasions, suffocation, choking, loss of sight, loss of hearing, dizziness, drowsiness, loss of consciousness, broken body parts, death or any other personal or property damage caused or alleged to have been caused by popping balloons, or damage to swimming pool filtration systems caused by broken balloons.
